135 Crash Description

Investigation at the scene indicated the following: Vehicle 3 faced south while stopped in traffic on Burrsville Road prior to the intersection with Route 88. Vehicle 2 and vehicle 1 traveled south on Burrsville Road directly behind vehicle 3. As vehicle 2 approached vehicle 3, vehicle 1 struck the rear of vehicle 2. The collision caused vehicle 2 to travel forward and collide with the rear of vehicle 3.

I spoke to driver 1 on scene and he stated the following:

Driver 1 trawled south on Burrsville Road directly behind vehicle 2. Vehicle 2 continuously stopped at every intersection on Burrsville Road and put the left blinker on. Vehicle 2 never made the left turn but instead sped off and continued to travel south on Burrsville Road. Vehicle 2 stopped to make a left turn into a parking lot on Burrsville Road and driver 1 attempted to pass vehicle 2 on the right. The front of vehicle 1 struck the rear of vehicle 2 which caused vehicle 2 to collide with vehicle 3.

Driver 2 parked his vehicle in the parking lot of United Medical Center and ran on foot prior to police arrival.

Ptl. Vendrell #228 responded to Driver 2's address and spoke with the owner of the vehicle. Ptl. Vendrell identified the owner as the operator of the vehicle and issued him summonses for the following:

Leaving the Scene of an Accident (E16007377)
 Careless Driving (E16007378)
 Reckless Driving (E16007379)
 Failure to Report an Accident (E16007380)
 Leaving the Scene of an Accident with Property Damage (E16007381)

I spoke to driver 3 on scene and he stated the following:

Driver 3 was stopped in traffic on Burrsville Road prior to Route 88. The rear of his vehicle was suddenly struck by the front of vehicle 2. The driver of vehicle 2 was a male, approximately mid to late 20s.

Driver 1 was at fault for the accident and I issued him summonses for Careless Driving (E16007370) and Driving While Suspended (E16007371).
