No injuries were reported on scene. Driver of vehicle 1 was issued a Carelees Driving Summons (T153875) for being at fault.

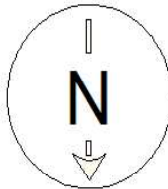
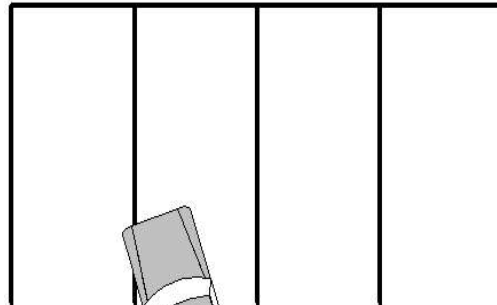
