135 Crash Description

Vehicle 1 and Vehicle 2 were located in the parking lot of 495 Jack Martin Boulevard in Brick, NJ. Vehicle 1 backing out of a parking space as Vehicle 2 was traveling straight ahead through the travel portion of the parking lot.

As Vehicle 1 was backing from it's parking stall, it collided with Vehicle 2.

Driver of Vehicle 1 claimed that the driver of Vehicle 2 was traveling too fast through the parking lot.

Driver of Vehicle 2 stated that he had just slowed for another uninvolved vehicle that was backing into a spot ahead of him.

No injuries were reported at the scene. A distance of 128 feet of visibility was measured from where Vehicle 2 began to where the collision occurred. Both vehicles were driven from the scene and no motor vehicle summonses were issued.

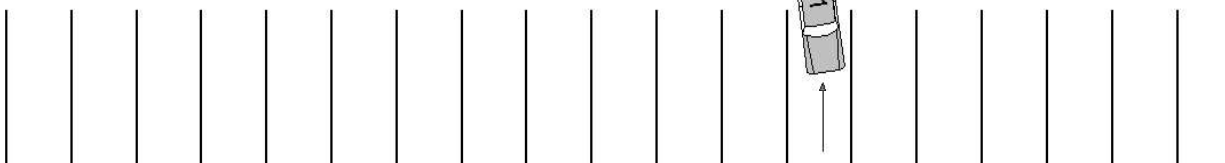
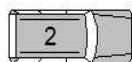
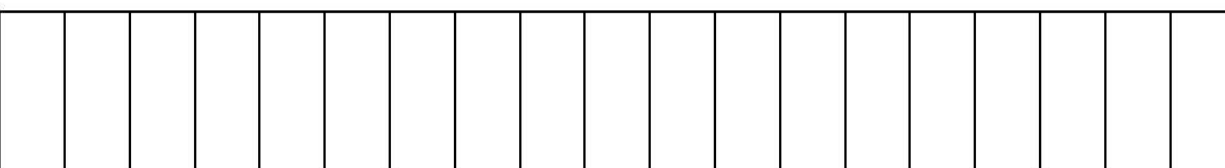
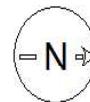
