Vehicle #1 was stopped in traffic in the left lane on Rt. 70 West at the intersection of Van Zile Rd. Vehicle #2 was stopped in front of V#1. The crash occurred when V#1 accelerated and impacted V#2.

The operator of V#1 stated she was stopped behind V#2 in the left lane of Rt. 70. The operator of V#1 stated she observed the traffic signal turn green and accelerated, impacting the rear of V#2. The operator of V#1 stated she did not observe V#2 still stopped in traffic.
