135 Crash Description

Vehicle #1 was making a left turn into the entrance of Professional Medical Arts Center at 525 Jack Martin Blvd from the North bound lane of Jack Martin Blvd. Vehicle #2 was traveling South on Jack Martin Blvd. Vehicle #2 struck the rear passenger side bumper of Vehicle #1 before he completed his turn into the parking lot.

Driver #1 advised he was traveling North on Jack Martin Blvd and made a left turn when his vehicle was struck by Vehicle #2. Driver #2 advised she was traveling South on Jack Martin Blvd when she struck Vehicle #1 after Vehicle #1 suddenly made a left turn in front of her vehicle from the North bound lane.

Based upon my observations and statements made by Driver #1 and Driver #2, I find Driver #1 at fault for failing to yield the right of way to vehicle #2.
