135 Crash Description

Driver 1 stated she was pulling into traffic from the Rt 70 east exit ramp onto Van Zile Rd. Driver 1 stated she pulled out into the left lane and did not see vehicle 2 traveling north on Van Zile Rd when they collided.

Driver 2 stated he was traveling north on Van Zile Rd when vehicle 1 pulled out from the jug handle and struck his vehicle.

Investigation revealed, Vehicle 1 was pulling into traffic from Rt 70 exit ramp onto Van Zile Rd traveling north. Vehicle 2 was traveling north on Van Zile Rd. The driver of vehicle 1 failed to yield to vehicle 2 causing the crash.

Both vehicles were at final rest upon my arrival. No injuries were reported on scene.
