145. Crash Description/Narrative

On March 4, 2022, I responded to the area of Route 88 and Jack Martin Blvd for a motor vehicle crash. Upon my arrival, I observed vehicle #1 with disabling front end damage. Vehicle #2 had moderate but functional damage to the rear of the vehicle.

Driver #1 explained he was attempting to get out of the way of a vehicle coming out of the Wawa, who crossed the double yellow line. While attempting to get out of the way he rear ended vehicle #2.

Driver #2 explained he was stopped in traffic waiting to make a left turn into Wawa's parking lot when vehicle #1 crashed into the rear of him.

There were no reported injuries at this time. Vehicle #1 was towed by Glen's towing.

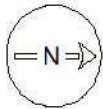
