145. Crash Description/Narrative

My investigation revealed the following: Vehicle 2 was parked in front of Ocean Medical Center 425 Jack Martin

blvd, dropping off a passenger. Vehicle 1 was stopped directly behind vehicle 2. Vehicle 2 was then preparing his

vehicle to leave and lifting the access ramp back into the vehicle. Vehicle 1 then attempted to pull around

vehicle 2 but did not have enough room to pull out. This caused vehicle 1 to contact the back rear driver side of

vehicle 2.

Driver 2 stated while waiting for the ramp to be lifted back into the vehicle, he was contacted by vehicle 1.

Driver 2 advised vehicle 1 then left the scene, but he was able to obtain a license plate.

Driver 1 responded to police headquarters to report the accident. Driver 1 advised she was attempting to get

around vehicle 2 but just contacted the rear of vehicle 2.

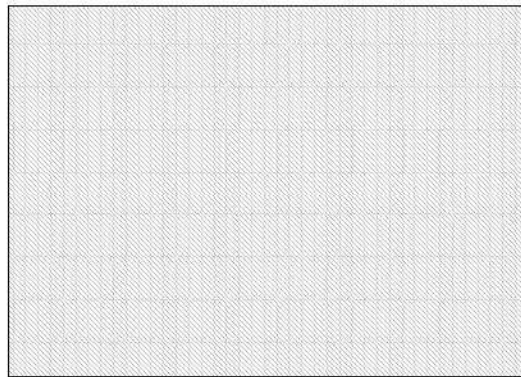

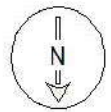
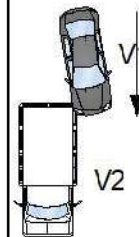
