145. Crash Description/Narrative

A two car, hit and run crash occurred in the parking lot of Walmart (1872 Rt. 88). The Hit and Run vehicle (V1) struck the unattended and parked V2. There were no reported injuries and V2 was able to be safely driven from the scene.

The driver of V2 provided the following information in regards to this crash:

He is an over night worker for Walmart. He parked his car facing north in front of the pharmacy entrance on the night of 04/02/2022. At approximately 0300 hours on 04/03/2022 he went back out to his vehicle and did not see any damage to the vehicle. Upon going back out to his vehicle a few hours later at 0700 he noticed that the plastic casing to his driver side mirror was next to his vehicle. He does not know who hit his vehicle or how it could have happened.

The plastic mirror casing had red paint transfer on the lower left side, indicative of a red vehicle crashing into the mirror. No further evidence was found at this time linking a possible hit and run vehicle.

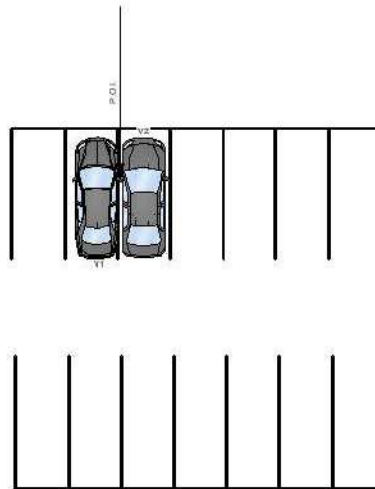
