145. Crash Description/Narrative

V1 and V2 were on Jack Martin Blvd. traveling North. just past Frank Neri Dr.

D1 related that he was traveling North on Jack Martin Blvd and did not notice V2 stopped attempting to make the left turn. D1 attempted to break and swerve to the left to avoid the collision, but V1 struck V2. crossed the double yellow lines and struck a curb.

D2 related that V2 and another uninvolved vehicle were stopped on Jack Martin Blvd. attempting to make a left turn into the parking lot for 455-459 Jack Martin Blvd. While waiting, V2 was struck in the rear by V1.

D1 advised he was uninjured and did not wish to be evaluated by Brick PD EMS.

D2 complained of neck/shoulder/abdomen pain, but did not wish to be evaluated by Brick PD EMS.

V1 sustained significant damage to the front/front passenger side. V2 sustained significant rear end damage.

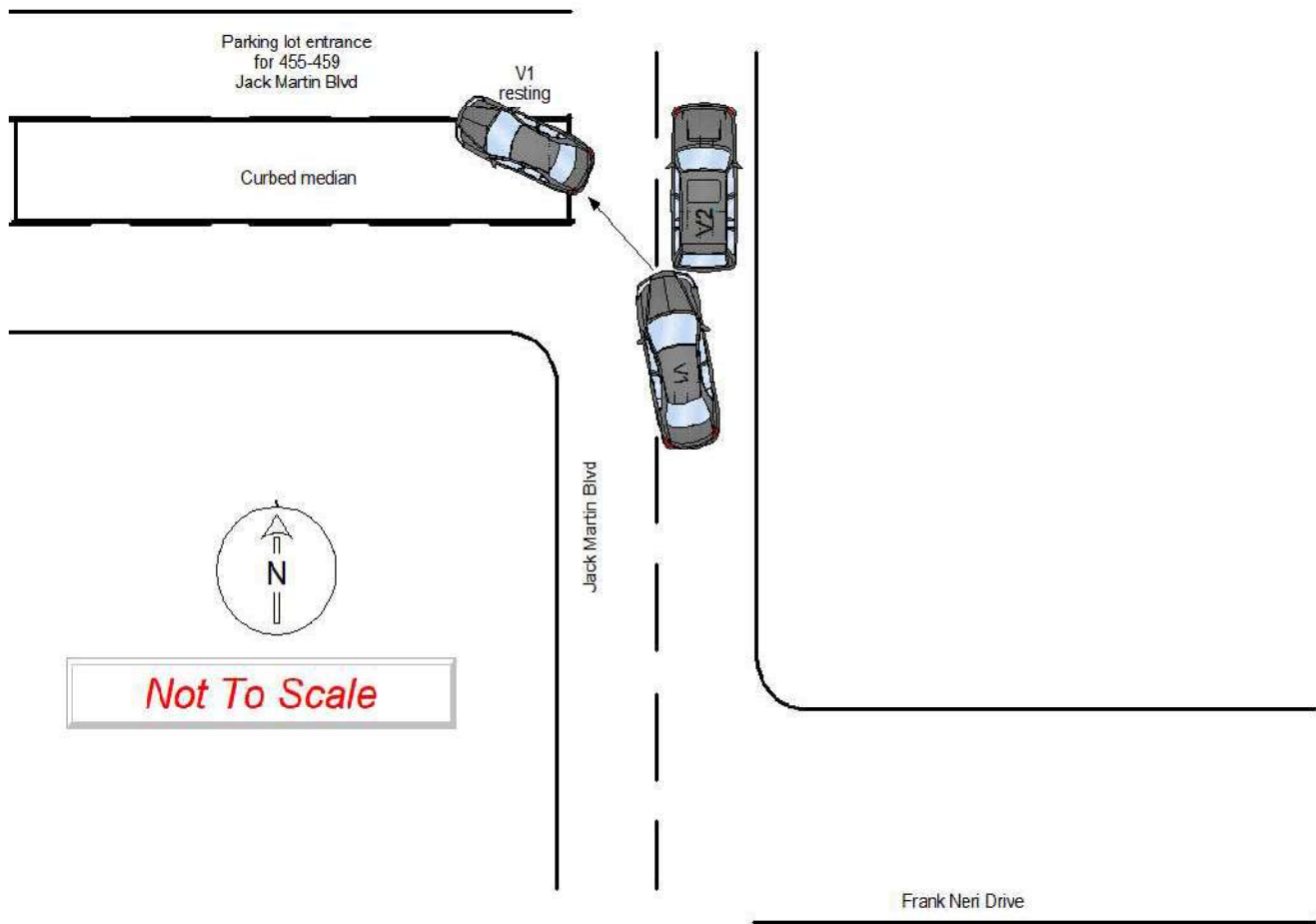
