145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a rear end crash while traveling westbound on RT 70 in the right lane.

The Driver of Vehicle #1 stated she was traveling westbound on RT 70 (green light) in the right lane when Vehicle #2 turned right into the right lane of RT 70 from Olden Street and then attempted to turn right into Brick Motor Inn (912 RT 70) minor damage along the front drivers side.

The Driver of Vehicle #2 stated she was at a complete stop (red light) at the intersection of Olden Street and RT 70 (westbound). Driver #2 stated she observed traffic westbound on RT 70 and once it was clear attempted to make a right turn. Driver #2 stated after making a right turn she attempted to make a quick turn into Brick Motor Inn and at that time her vehicle was struck by vehicle #1 in a rear end crash. Vehicle #2 had minor drivers side rear end damage.

I was able to observe video surveillance from Brick Motor Inn. On video I observed Vehicle #2 stopped at the red light waiting for traffic to pass. Once traffic past Vehicle #2 made a right turn onto RT 70 and slowed down to make a turn into Brick Motor Inn. At that same time Vehicle #1 changed lanes from the center lane to the right

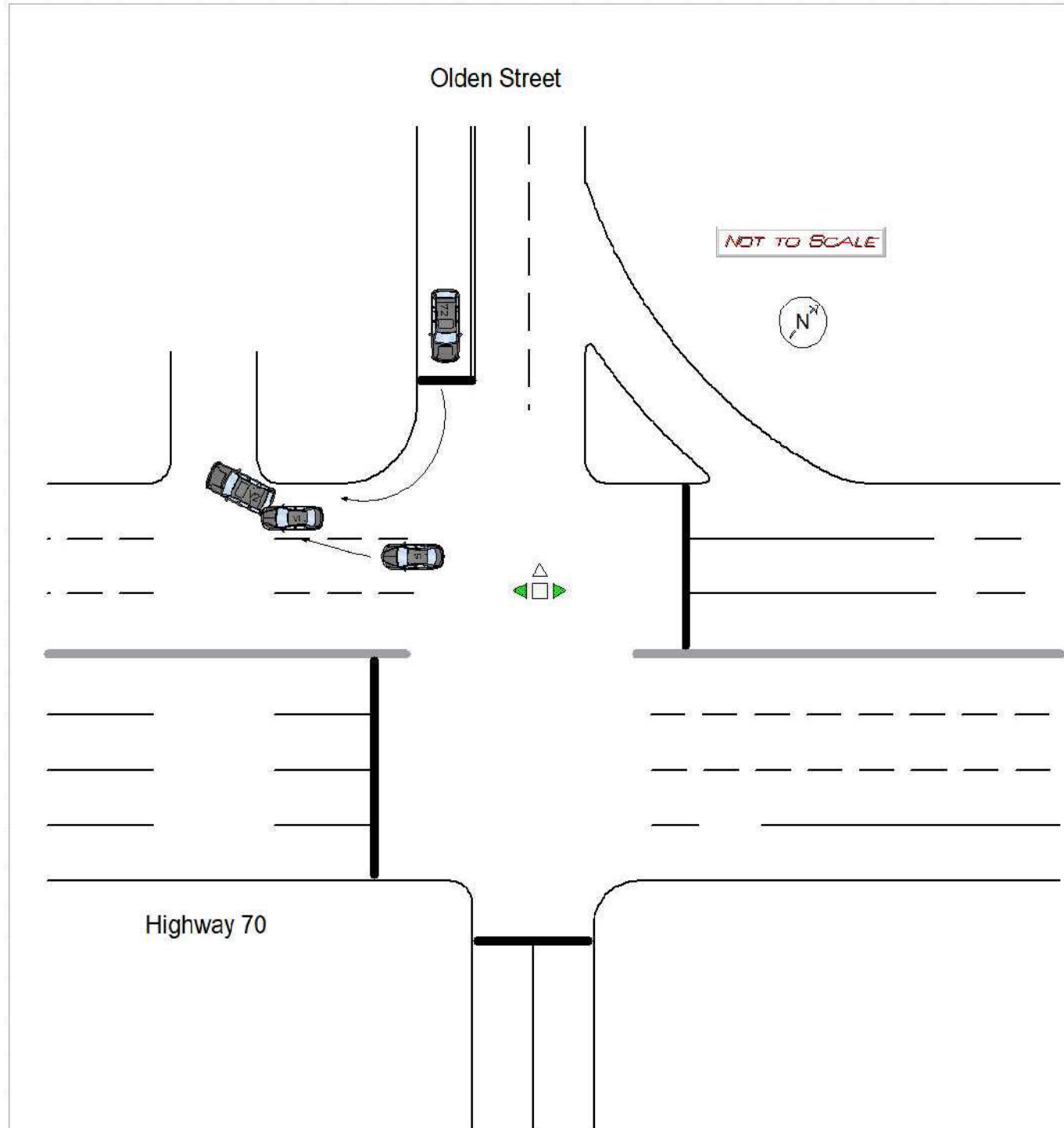
