135 Crash Description

Vehicle #2 was traveling southbound on Burrsville Rd. approaching the intersection of Rt. 88. Vehicle #1 was traveling directly behind Vehicle #2.

Vehicle #2 stopped at the stop sign awaiting a left turn onto Rt. 88. Vehicle #1 struck the rear of Vehicle #2.

Driver #1 stated she was looking right before turning left onto Rt. 88. She thought Vehicle #2 had turned left onto Rt. 88 but had only inched forward. She accelerated to turn left on Rt. 88, but instead struck the rear of Vehicle #2.

Driver #2 stated she had inched forward in an attempt to turn onto Rt. 88, but had stopped before entering the intersection when she was struck from behind by Vehicle #1.

Both vehicles sustained minor damage. Both vehicles were moved prior to my arrival.
