Vehicle 2 was stopped in traffic on Rt. 88 approaching Jack Martin Blvd. Vehicle 1 was behind vehicle 2. The crash occurred when vehicle 1 impacted vehicle 2. No injuries were reported and the vehicles were moved prior to my arrival.

On scene there was no visible damage to vehicle 1 and visible damage to the rear of vehicle 2.

The driver of vehicle 1 stated she was unable to stop in time. The driver of vehicle 2 stated he was in traffic when he was impacted.

The driver of vehicle 1 was issued summons E16-6441 for careless driving and summons E16-6442 for failure to use a car seat.
