135 Crash Description

On 09/26/16 at approximately 0821 hours Ptl. Ziobro 196 and I responded to Rt 88 and Post Rd. for a motor vehicle accident. Upon arrival I observed vehicle 1, a gray Honda Civic bearing NJ Reg. H67FKW, operated by, Christina Caudill. Vehicle 2 was a silver delivery truck bearing NJ Reg. XG814V, operated by John Calandrillo. Vehicle 1 was traveling eastbound on Rt. 88 in the left lane. Vehicle 2 was traveling eastbound in the right lane. Vehicle 1 made a right turn from the left lane onto Post Rd. The front of vehicle 2 collided with the rear right of vehicle 1 due to vehicle 1 cutting in front of vehicle 2. Caudill, the driver of vehicle 1 stated she was using her GPS which told her to turn right onto Post Rd. She also stated that she saw the delivery truck, but it seemed further away. Calandrillo, the driver of vehicle 2 stated vehicle 1 cut in front of him and that he had nowhere to go, forcing him to collide with her.

Caudill had a complaint of pain in her left shoulder, however she refused medical treatment at this time.
