135 Crash Description

Vehicles 1 and 2 were in the parking lot of Walgreens (1890 Route 88). Vehicle 1 was backing from a parking space heading west and Vehicle 2 was traveling straight ahead heading south in the parking lot. Vehicle 1 collided with Vehicle 2 while backing from the parking space.

Driver 1 stated that he did not see Vehicle 2 when he started to back from the parking space and was surprised when the collision occurred. Driver 2 stated that Vehicle 1 backed out of the space and collided with her vehicle. Both drivers reported no injuries on scene and both vehicles were able to be driven away.
