135 Crash Description

Driver of vehicle #1 stated he was traveling west on the Rt 70 ramp entering Van Zile Rd. He stated the sun blinded him and he did not see vehicle #2 stopped in front of him. He rear ended vehicle #2.

Driver of vehicle #2 stated he was stopped in traffic and was rear ended by vehicle #1.

My investigation revealed driver #1 rear ended driver #2. There was a substantial amount of sun glare in the area in which the accident occurred and it may have contributed to the accident.
