## 135 Crash Description

The driver of vehicle #1 stated he was attempting to turn left out of a parking lot, on to Jack Martin Blvd. southbound. He stated that he never observed vehicle #2 and began to make the left turn. He stated that by the time he observed vehicle #2 it was too late and he struck the middle driver side of the vehicle. He further advised that the crash was entirely his fault.

The driver of vehicle #2 stated he was traveling southbound on Jack Martin Blvd, approaching the intersection of Rt. 70. He stated vehicle #1 attempted to turn left just as he was passing by. He stated the driver of vehicle #1 never observed him and struck the driver side of his vehicle.

Minor damage to both vehicles.

No injuries reported.

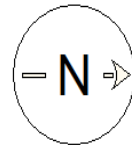
Motor Vehicle Crash Diagram

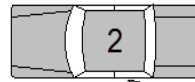

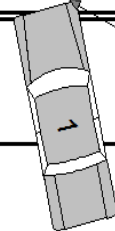
