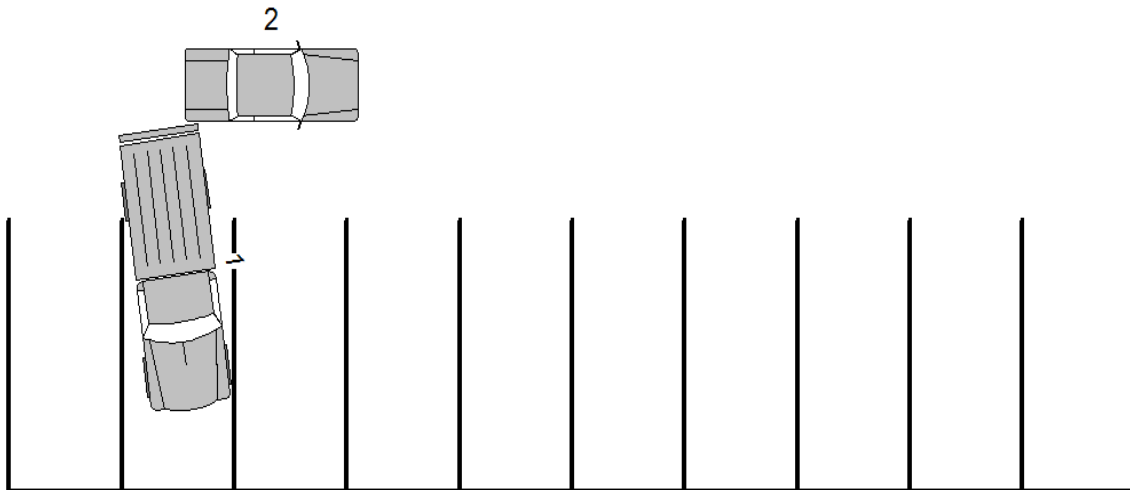
Motor Vehicle Crash Diagram
