135 Crash Description

Vehicle 1 traveling westbound on Olden Street, approaching West Princeton Avenue. Vehicle 2 traveling southbound on West Princeton Avenue, approaching Olden Street.

Driver 2 stated as she approached the intersection, she saw Vehicle 1 and believed Vehicle 1 was going to stop. Driver 2 advised as she entered the intersection, Vehicle 1 ran the stop sign and struck her truck. Driver 2 did not remember what happened after that, other than she was in her vehicle, which was upside down.

Driver 1 stated she was not familiar with the area and was heading to a wedding. She advised she was driving slowly, checking to see where she was at, when Vehicle 2 came out of no where.

Investigation at the scene revealed Vehicle 1 failed to stop for the stop sign and struck Vehicle 2 in the driver's side rear. Vehicle 2 began to spin counterclockwise, left the roadway and struck the utility pole on the southwest corner of the intersection. Vehicle 2 then began spinning clockwise and rolled onto its roof.

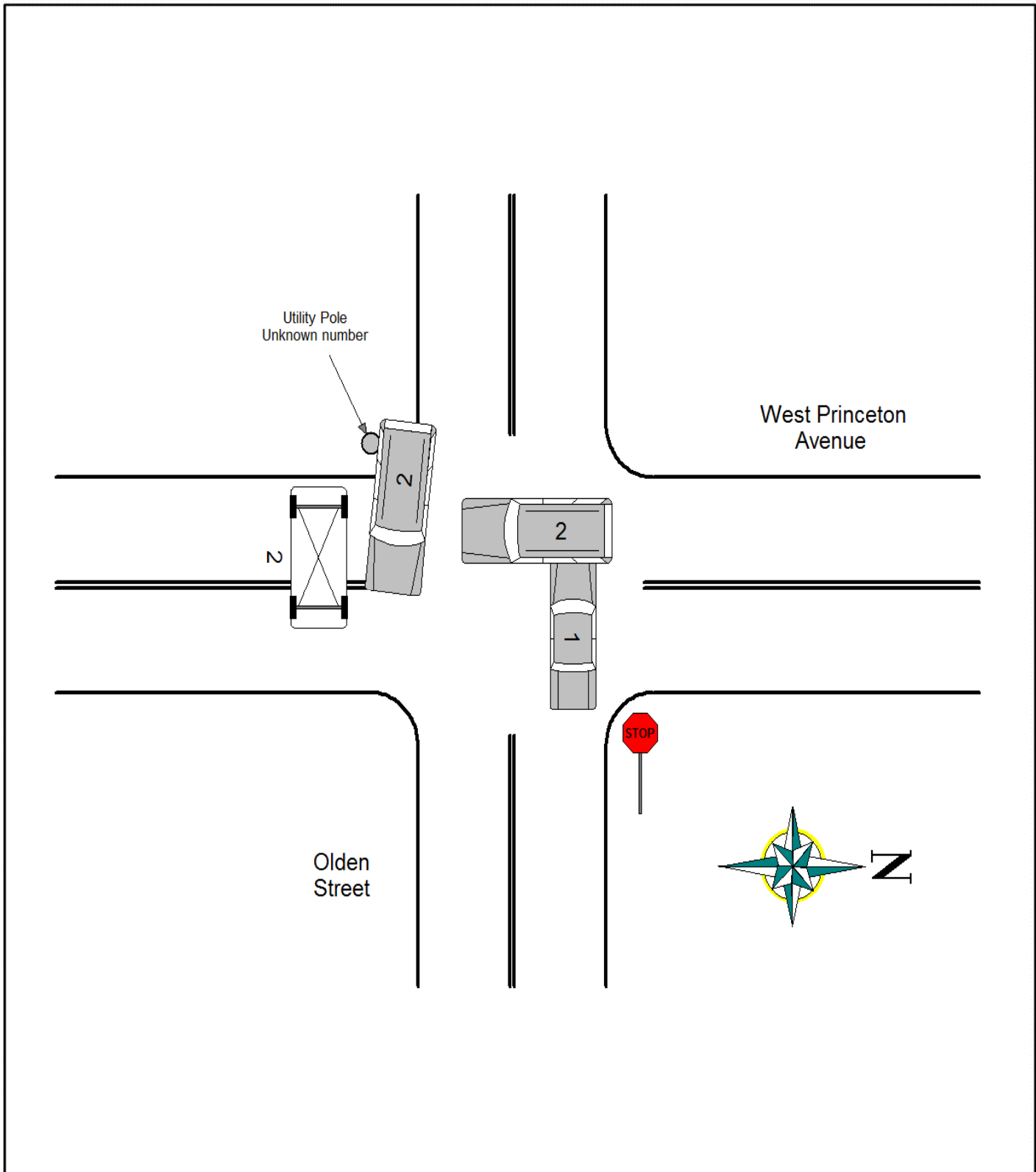
