At the conclusion of my investigation, Driver 1 is at fault.

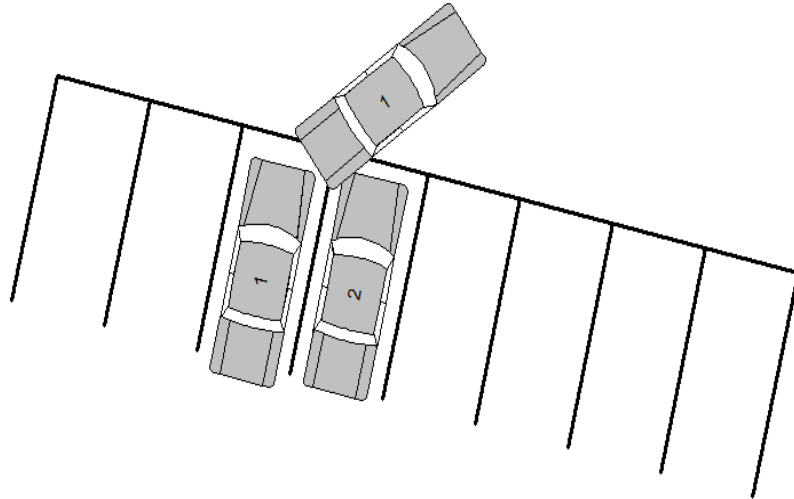

Motor Vehicle Crash Diagram

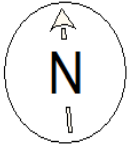
