145. Crash Description/Narrative

The crash occurred in the parking lot of 2055 RT 88.

Vehicle 1 was starting out of a parking spot.

Vehicle 2 was traveling through the parking lot.

Vehicle 1 failed to observe vehicle 2 traveling through the lot, resulting in the crash.

The driver of vehicle 1 stated he was pulling forward, out of a parking spot. He did not see vehicle 2 traveling in front of him, and when he did he was unable to stop in time resulting in the crash. He did not report any injuries on scene. I observed damage to the front bumper on the driver's side.

The driver of vehicle 2 stated, she was traveling through the parking lot when she was struck by vehicle 1. She did not report any injuries on scene. I observed disabling damage to the middle passenger side of the vehicle.

Due to the damage it was towed by Andrew's Auto Body.

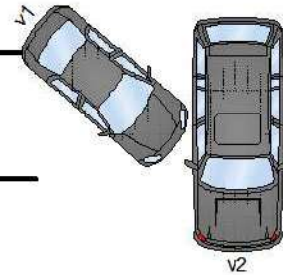
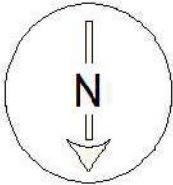
Motor Vehicle Crash Diagram
