145. Crash Description/Narrative

The driver of vehicle 1 advised she was exiting the plaza for 1800 Route 88 attempting to make a right turn out of the lot onto Route 88 East bound. The driver advised she looked both ways did not observe any vehicles and then proceeded onto route 88. As the driver entered Route 88 (e/b) the front of her vehicle collided with the passenger's side middle of vehicle 2. The driver added she did not observe vehicle 2 prior to exiting the lot.

The driver of vehicle 2 advised she was traveling on Route 88 (e/b) when the driver of vehicle 1 pulled out of a parking lot and collided with the passenger's side middle of her vehicle.

Vehicle 1 sustained damage to the front while vehicle 2 sustained damage to the passenger's side middle.

My investigation revealed vehicle 1 to be at fault for failing to yield the right of way.

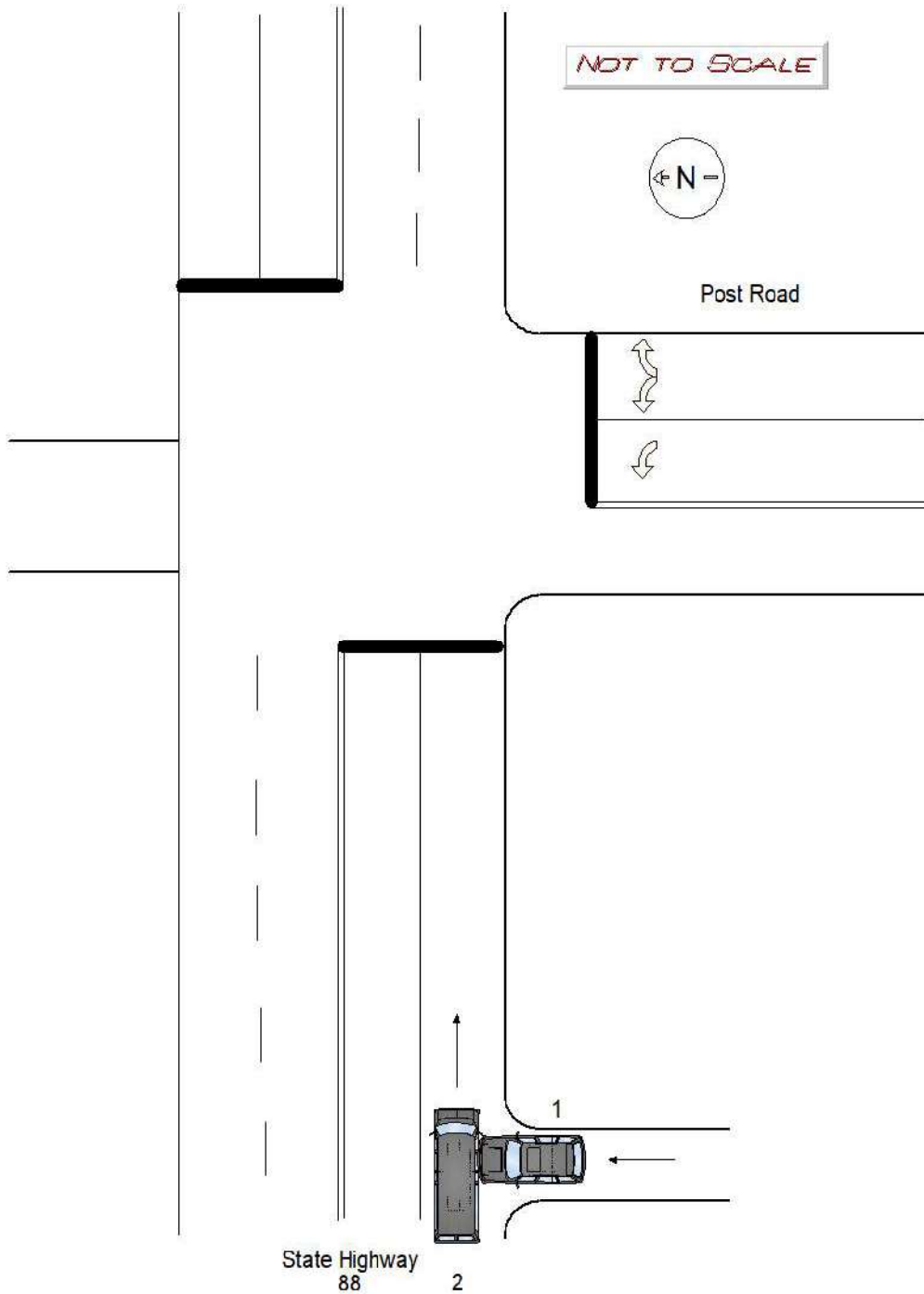
