145. Crash Description/Narrative

A motor vehicle collision occurred on Route 88 east bound approximately 100 feet west of the intersection with Laurel Brook Drive. Vehicle 02 was traveling on Route 88 east bound approaching the intersection with Laurel Brook Drive when he came to a sudden stop in traffic. Vehicle 01 was traveling directly behind vehicle 02, failed to stop, and the front end of vehicle 01 struck the rear end of vehicle 02.

While on scene, there were no reported injuries and both parties declined medical attention.

Driver 01 stated he was traveling behind vehicle 02 on Route 88 following the flow of traffic. Driver 01 said he observed vehicle 02 come to sudden stop in traffic due to another uninvolved vehicle ahead of him stop suddenly. Driver 01 explained he pressed down onto his brakes but was unable to stop in time to prevent the motor vehicle collision.

Driver 02 stated he was traveling on Route 88 east bound when another vehicle two vehicles ahead of him came to a sudden stop in traffic in the area of the intersection with Laurel Brook Drive causing traffic behind that vehicle to have to brake suddenly. Driver 02 explained he pressed down onto his brakes and came to a complete

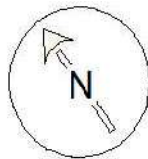

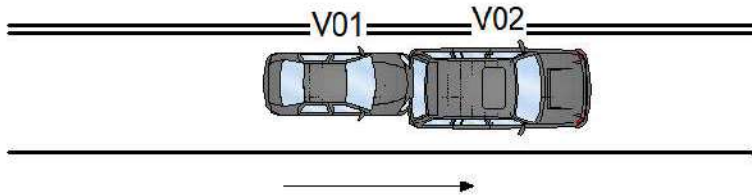
144 Crash Diagram (NOT TO SCALE)
