145. Crash Description/Narrative

Vehicle one was traveling southbound on Burrsville Road approaching the intersection of State Highway 88. Vehicle one traveled onto the grass median striking the stop sign at the intersection of Burrsville Rd / State Highway 88. The driver continued traveling onto State Highway 88 heading eastbound.

Driver one stated that he was aware he struck the stop sign at the intersection of Burrsville Road and State Highway 88. Driver one stated he did not feel the need to stop because no one was injured at the scene.

Vehicle one sustained moderate but functional damage to the front of the vehicle. Vehicle one's license plate was in the middle of the road along with a part of the vehicle.

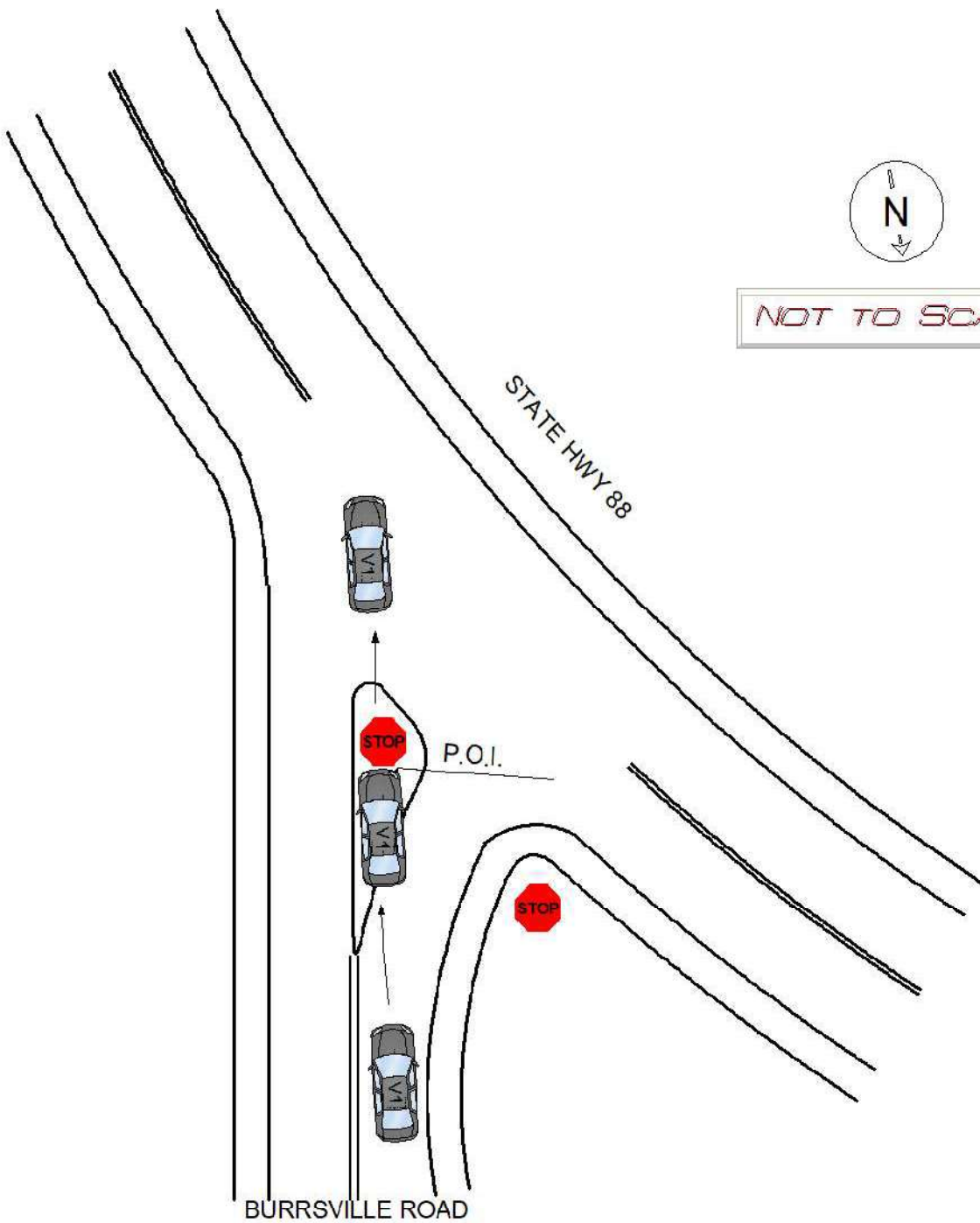
