145. Crash Description/Narrative

Vehicle 1 was traveling West on RT 88 approaching the intersection of RT 88 and Olden Street. Vehicle 2 was traveling West on RT 88 next to Vehicle 1. The trailer attached to Vehicle 1 struck the right front of Vehicle 2 causing damage to Vehicle 2.

The driver of Vehicle 1 stated that he was traveling West on RT 88 approaching the intersection of Rt 88 and Olden Street. The driver of Vehicle 1 stated that as he approached the intersection, the driver of Vehicle 2 turned into the side of the trailer that he was towing.

The driver of Vehicle 2 stated that she was driving West on RT 88 approaching the intersection of RT 88 and Olden Street. The driver of Vehicle 2 stated that as the two lanes merged into one, Vehicle 1 merged into her vehicle. The driver of Vehicle 2 stated that the driver of Vehicle 1 did not account for the trailer that he was towing when merging.

After speaking to both drivers and investigating the crash, Vehicle 1 was determined to be at fault. The diver of Vehicle 1 should have been more attentive when merging. The driver of Vehicle 1 was issued the following summons:

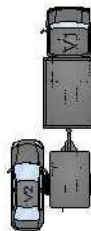
