145. Crash Description/Narrative

Vehicle #1 was traveling in the right lane of Rt. 70 eastbound approaching the intersection of Olden Street.

Vehicle #2 was in the right lane of the ramp for Rt. 70 waiting for the traffic signal to turn green and cross the intersection onto Olden Street. After Driver #2's signal changed to green she proceed into the intersection and was struck by Vehicle#1.

Driver #2 stated that she was in the right lane of the ramp from Rt. 70 to Olden Street waiting for the traffic signal to change. Once the signal changed she proceeded into the intersection and was struck in the side by Vehicle #1.

Driver #1 stated that he realized his traffic signal was red too late and attempted to stop but he was unable to before striking the side of Vehicle #2.

After my investigation I have determined that Driver #1 is at fault for the incident.

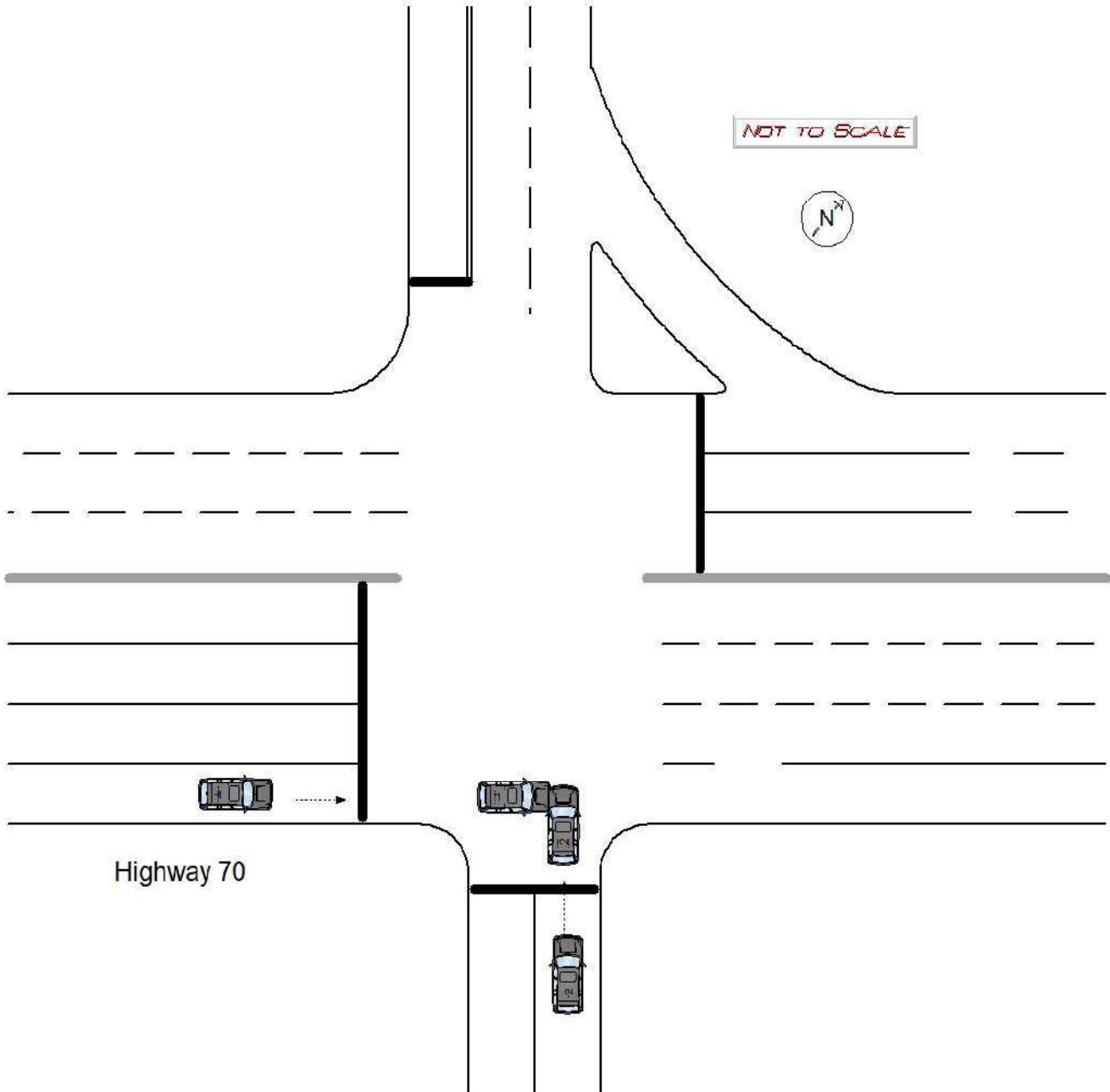
