145. Crash Description/Narrative

On April 14, 2022, I responded to the area of Route 88 and Post Road for a motor vehicle crash. Upon arrival, I observed two vehicles in the Verizon parking lot. Vehicle #1 had moderate but functional front passenger damage to her vehicle. Vehicle #2 had moderate but functional damage to the driver side rear of his vehicle.

Driver #1 explained she was traveling in the left lane when she turned on her turn signal to change lanes. As she was changing lanes Driver #1 explained vehicle #2 was speeding down Route 88 in the lane she went to change into. When she began to change lanes she struck the driver side rear of his vehicle.

Driver #2 explained he was traveling on Route 88 when he was passing vehicle #1 she begun to change lanes. As she changed lanes she struck the driver side rear of his vehicle.

After my investigation, I found Driver #1 the at fault vehicle.

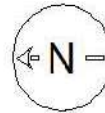
