135 Crash Description

Driver of Vehicle 1 was on Route 88 in the eastbound lane. Driver of Vehicle 2 was on Route 88 in the westbound lane.

Driver of Vehicle 1 stated she was attempting to turn left into the parking lot for 1620 Route 88 prior to the crash. She stated as she was turning, her purse fell off the seat, causing her to grab it. She said by the time she fixed her purse, Vehicle 2 was already in front of her.

Vehicle 1's front struck Vehicle 2's front, causing significant damage to both vehicles. Driver of Vehicle 1 had a complaint of shoulder pain and a minor laceration to her left hand. Driver of Vehicle 2 had a complaint of pain to her shoulder and neck. Passenger of Vehicle 2 had a complaint of pain to her right leg and foot.

All three victims were transported to Ocean Medical Center by Brick Police EMS. Driver of Vehicle 1 was issued summons E16 005345 for careless driving. Vehicle 1 was disabled and towed from the scene by PPTD. Vehicle 2 was disabled and towed by Joe's Service Center.
