Driver #3 explained she began in traffic when she was rear ended by Vehicle #2.

Driver #2 explained he began in traffic when he looked in his rear view mirror, and saw Vehicle #1 coming at him in an accelerated speed and was not stopping. He explained that Vehicle #1 collided into the rear of his vehicle. Driver #2 further explained the impact from Vehicle #1 pushed his vehicle into rear of Vehicle #3.

The driver of vehicle #1 failed to stop for traffic causing her to crash into Vehicle #2.

Driver #1 and Driver #2 were both transported to Ocean Medical Hospital for further treatment by Brick EMS.

In my investigation the statements that the driver's gave corroborated with my findings. Driver #1 was not paying attention to traffic causing the crash.
