135 Crash Description

Vehicles 1 and 2 were in the drive-through lane of the Wendy's restaurant located at 101 Jack Martin Boulevard. Vehicle 1 was stopped behind Vehicle 2. Vehicle 2 was stopped in the line of traffic at the drive-through.

Driver of Vehicle 1 stated that his foot slipped off the brake pedal and his vehicle rolled forward into the rear of Vehicle 2.

Minor cosmetic damage only to Vehicle 2's rear bumper. No injuries were reported at the scene, and no motor vehicle summonses were issued.
