135 Crash Description

Owner of vehicle #2 was parked at 1930 Rt 88 (K-Mart parking lot). Vehicle #2 stated he came outside and was approached by a woman who stated she observed an SUV bearing NJ Registration YHM75W back up into his parked vehicle. The woman described the vehicle as an SUV and did not give a make, model or color description. The witness was unidentified and left the scene prior to my arrival.

Vehicle #2 sustained damage to the right rear bumper. The paint transfer indicated the suspect vehicle may possibly be a red vehicle. The suspect vehicle registration provided by the witness is beige in color. At this time there is no further information on the suspect vehicle.

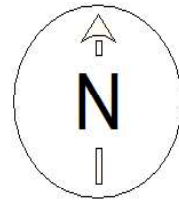
