135 Crash Description

Driver of vehicle 1 stated she was traveling in the left lane east on Rt 70 approaching Van Zile Road. Driver of vehicle 1 stated while traveling, vehicle 2 suddenly stopped causing her vehicle to strike the rear of vehicle 2.

Driver of vehicle 2 stated she was traveling in the left lane east on Rt 70 approaching Van Zile Road. Driver of vehicle 2 stated while stopping she felt vehicle 1 strike the rear of her vehicle.

Investigation revealed; Vehicle 1 and 2 both were traveling east on Rt 70 in the left travel lane. Vehicle 2 was stopping in traffic as vehicle 1 followed too closely and struck the rear of vehicle 2, causing the crash.

There were no reported injuries at the time of the crash.

Both vehicles were not in the original point of impact upon my arrival.
