135 Crash Description

Vehicle 1 was traveling east on Jack Martin Boulevard approaching the intersection of Burrsville Road. Vehicle 1 was in the left lane of travel behind another vehicle. As the vehicle in front of Vehicle 1 approached the intersection, the traffic signal was green, the vehicle stopped prior to entering the intersection. That vehicle stopped to let Vehicle 2, an Ambulance with it's lights and siren activated, proceed through the intersection. Vehicle 1 went around, to the right, of the vehicle it was following. Vehicle 1 entered into the intersection and failed to observe Vehicle 2 in the middle of the intersection. Vehicle 1 struck the left middle portion of Vehicle 2 with the front of Vehicle 1.

Driver 1 stated she was traveling, in the left lane of travel, behind a vehicle on Jack Martin Boulevard approaching the intersection of Burrsville Road. Driver 1 observed the traffic signal to be green. Driver 1 stated the vehicle in front of her stopped at the green traffic signal. Driver 1 proceeded around to the right of the vehicle in front of her and proceeded into the intersection. Driver 1 stated she then noticed Vehicle 2 in the intersection and struck Vehicle 2 with the front portion of Vehicle 1.

Driver 2 stated he was traveling north on Burrsville Road approaching the intersection of Jack Martin Boulevard with the emergency lights and siren activated. Driver 2 stopped at the red traffic signal, when the intersection was clear Driver 2 proceeded into the intersection. As Driver 2 was about midway through the intersection, Vehicle 1 entered into the intersection and struck the left middle portion of Vehicle 2 with the front portion of Vehicle 1.

There were no reported injuries and both vehicles were driven from the scene of the crash.

Upon completion of my investigation, I find Vehicle 1 to be at fault for the crash. Vehicle 2, and ambulance responding to an emergency with the lights and siren of the vehicle activated, stopped at the red traffic signal. When the intersection was clear, indicated by other motorists not entering into the intersection, Vehicle 2 proceeded into the intersection. Vehicle 1, who was following another vehicle went around the vehicle which yielded the right away for Vehicle 2. Vehicle 1 struck Vehicle 2 in the intersection. No summonses were issued.

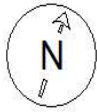
