135 Crash Description

The crash occurred on Route 88 Eastbound approximately 20 feet from Jack Martin Rd.

Driver #2 stated he was the first vehicle to the traffic light. He was coming to a stop when vehicle #1 struck him from behind. Driver #2 got out of the vehicle and walked to the rear of his vehicle to investigate the damages. Driver #1 sat in his vehicle and did not move from the driver's seat. Driver #2 stated he went up to the driver side window of Vehicle #1 and said you "hit my car." At that time driver #1 did nothing but wave his hand as if he did not hit him.

Driver #2 stated he told driver #1 to pull over onto the side of the road to get out of traffic. At that time Vehicle #1 drove past vehicle #2 and processed to go Eastbound on Route 88 to leave the scene. Driver #2 stated he followed vehicle #1 until he stop at the Quick Check located at 2108 Route 88. At that time Driver #2 called the police.

Driver #1 did not make a statement and was arrested for driving while intoxicated (see Ptl. Docherty's case report). Vehicle #1 was towed as per John's Law to Brick Performance.

Driver #2 advised he was not injured.

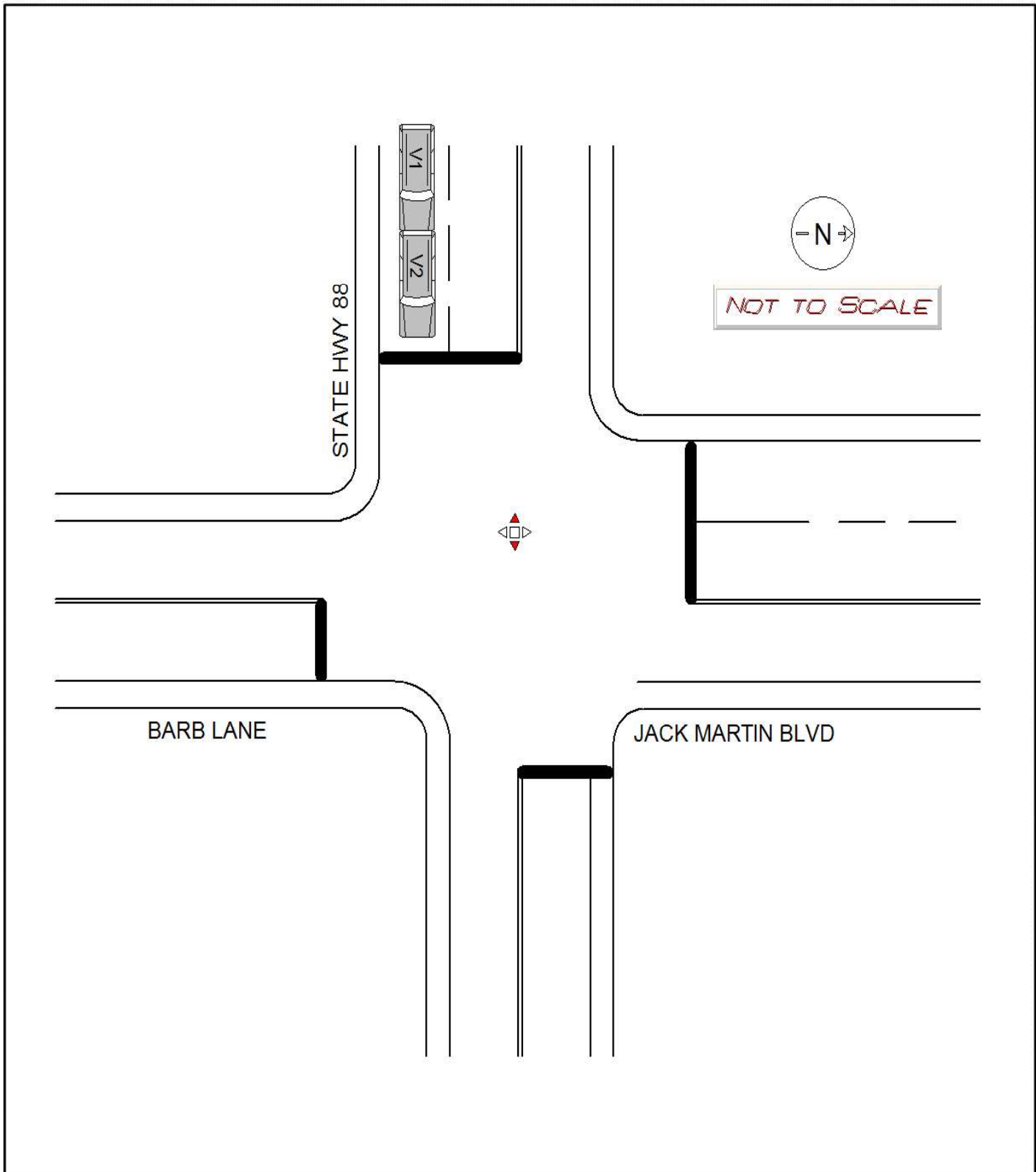
