Driver of vehicle #2 stated she was traveling westbound on Rt. 88 when she was struck by vehicle #1

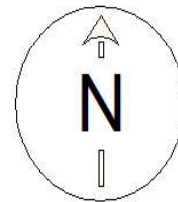

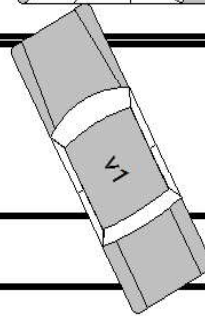
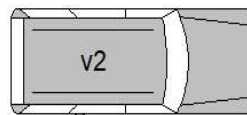
Motor Vehicle Crash Diagram
