135 Crash Description

On 6/15/16 at 1403 hours I was dispatched to 425 Jack Martin Blvd in reference to a two car motor vehicle accident in the parking lot. Upon arrival I observed both vehicles had moved from the scene of the accident and were parked in separate parking stalls.

Driver 1 advised she was backing out of her parking stall and did not see vehicle 2 until she crashed into it.

Driver 2 advised he was backing out of his parking stall and was about to put the vehicle in drive when he observed vehicle 1 backing up in his direction. Before he could move out of the way vehicle 1 crashed into his vehicle.

Investigation at the scene revealed both vehicles were parked in parking stalls located directly across from another. Due to the damage located on the left middle of vehicle 2 it was determined he was almost fully backed out. Vehicle 1 then backed up and crashed into vehicle 2 with her lower left bumper.

Both vehicles were moved prior to my arrival and no injuries were reported at this time. Driver 1 was issued a summons for 39:4-97 on E16-003746.
