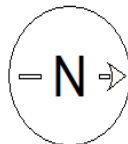
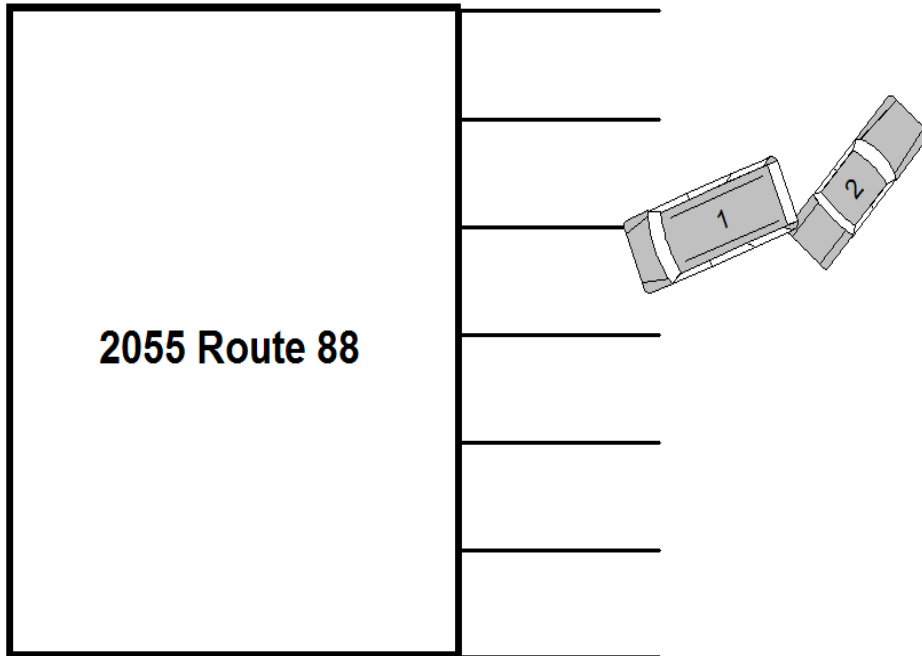
Based on my investigation and observations on scene I determined Vehicle 1 to be at fault for the motor vehicle crash.
