135 Crash Description

Vehicle 2 was traveling south on Burrsville Rd., approaching a red traffic signal at the intersection with Jack Martin Blvd. Vehicle 1 was traveling directly behind Vehicle 2. As Vehicle 2 came to a stop, the driver of Vehicle 1 stated she pressed the gas pedal by mistake, instead of the brake pedal. Vehicle 1 accelerated and the front of Vehicle 1 crashed into the rear of Vehicle 2, causing damage to both vehicles.

The driver of Vehicle 2 stated she did not believe she was injured from the crash, and refused medical treatment while on scene, but stated she was going to take herself to the hospital after to get checked due to a preexisting injury.

Vehicle 1 had United Services insurance out of Massachusetts.
