135 Crash Description

Vehicle 1 and 2 were located in the parking lot of Laurel Square (1930 RT 88). Vehicle 2 was parked and unoccupied in the area near the Cash Converters in row number 10 and five spaces from the main thoroughfare. Vehicle 1 was traveling through the lot and pulled into a space directly next to Vehicle 2 along the passenger side. While negotiating the vehicle into a parking space, the front driver side corner of Vehicle 1 impacted the rear passenger corner of Vehicle 2 causing minor damage.

The driver and passenger of Vehicle 1 disputed the fact that Vehicle 1 impacted Vehicle 2 although there were visible markers on both vehicles. The crash was also witnessed by a third party and a witness statement was obtained on scene and submitted along with this report.

Minor damage was noted to each vehicle and both vehicles were able to be driven away.
