135 Crash Description

Vehicle 2 was traveling west on Olden Street and struck Vehicle 1 which was traveling south out of the Home Depot parking lot, attempting to turn left onto Olden Street.

Driver of vehicle 1 stated traffic on Olden Street was stopped and she was attempting to make a left hand turn out of the Home Depot parking lot. Driver 1 stated vehicle 2 exited the right lane, entered the left lane, and struck her vehicle while she was attempting to turn.

Driver of vehicle 2 stated she was traveling west on Olden Street when vehicle 1 pulled out in front of her, causing her to strike vehicle 1.

It is my observation that the cause of the crash was due to driver 1 inattention and driver 1 failing to yield to traffic.

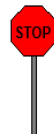
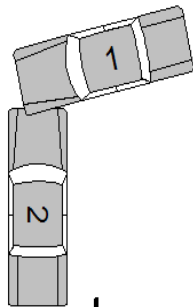
Motor Vehicle Crash Diagram
