135 Crash Description

Vehicle 1 was backing out of a parking spot at the Dunkin Donuts -2138 Rt 88.

Vehicle 2 was facing West in the lot of Dunkin Donuts -2138 Rt 88 ,and was stopped waiting for traffic to pass to pull out onto Rt 88 West.

As vehicle 1 backed up, vehicle 1 collided with vehicle 2. There were no reported injuries at the scene, there was no visible damage observed to vehicle 1, and minor damage to the right lower rear of vehicle 2.

The driver of vehicle 1 stated as she was backing up, vehicle 2 was stopped waiting to pull out onto Rt 88 West. Then vehicle 2 backed up slightly as she was continuing to back up and the two cars collided.

The driver of vehicle 2 stated he was stopped in the parking lot of the Dunkin Donuts-2138 Rt 88 waiting for traffic to pass so he could pull out onto Rt 88 West when vehicle 1 backed up into his vehicle. Driver of vehicle 2 stated he did not back his vehicle up prior to the collision.
