135 Crash Description

Crash occurred on Burrsville Rd. approximately 20 feet north of RT 88.

Driver #2 stated she was stopped at the stop sign waiting for traffic to clear. She advised she moved up a little bit to see if it was clear and was subsequently struck from behind by vehicle #1.

Driver #1 stated he was stopped behind vehicle #2 on Burrsville Rd. He advised vehicle #2 started to go, so he too started to go. Driver #1 advised vehicle #2 came to a stop for oncoming traffic and he could not stop in time, subsequently striking the rear of vehicle #2.

Both drivers advised they were not injured.
