145. Crash Description/Narrative

Crash investigation revealed that Vehicle 1 was traveling straight and passed Vehicle 2 which was waiting to back out of its parking spot. Once it was clear to back up, Vehicle 2 then began to back out of its parking spot. At that time, Vehicle 1 then unexpectedly began to back up straight approximately 55 feet directly into Vehicle 2.

Driver of Vehicle 1 stated that he pulled into a parking spot and backed up. He advised that he did not know that Vehicle 2 was behind him.

Driver of Vehicle 2 stated that he was waiting to back out of his parking spot until Vehicle 1 passed him. Once Vehicle 1 passed him and there were no other cars coming, he then began to back out of the parking spot. At that time, driver of Vehicle 1 then decided to put his car in reverse and backed straight directly into him.

Driver of Vehicle 1 was subsequently arrested for driving under the influence as a result of this accident (See Ptl. Patrick's #296 Case Report for further). No injuries were reported on scene. Vehicle 1 was impounded under John's Law by Legacy Towing. I was able to view surveillance footage from the Wawa which showed that Vehicle 1 was at fault for this crash. Vehicle 1 was traveling straight, came to a stop, shifted into reverse, and backed

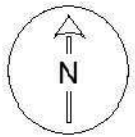

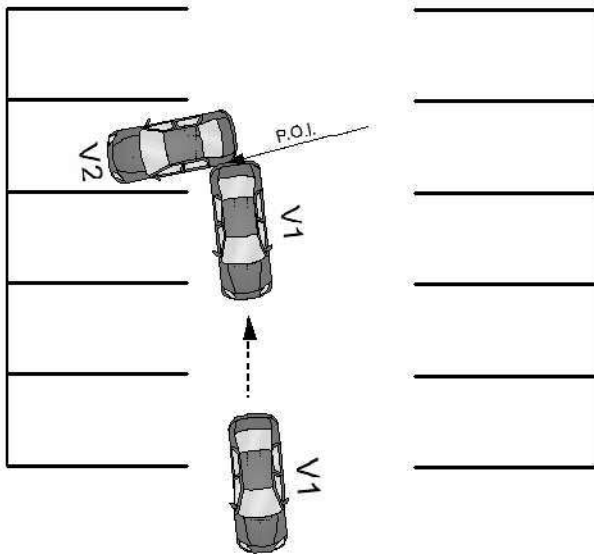
