145. Crash Description/Narrative

Vehicle #1 was traveling westbound on Route 88 approaching the intersection of Midstreams Road. Vehicle #2 was traveling directly behind Vehicle #1.

Driver #1 stated she was stopped in traffic when she decided she needed to try and get into the Welsh Farms located at 2085 Route 88. She began backing up in order to make the left turn into the plaza. As she was backing the right rear of her bumper struck the front of Vehicle #2.

Driver #2 stated he was stopped in traffic when Vehicle #1 started backing up in the lane of travel. He said that Driver #1 saw someone in the parking lot of the Welsh Farms and tried turning into the lot. The rear bumper of Vehicle #1 struck the driver's side front fender on Vehicle #2.

Based on my observations and statements made by both drivers, I determined Driver #1 to be at fault for the crash.

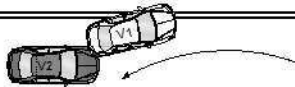
