145. Crash Description/Narrative

Vehicle 1 was traveling East on Route 88. As Vehicle 1 approached the intersection of Jefferson Drive,

Vehicle 1 left the roadway to the right. Vehicle 1 struck a utility pole with Vehicle 1's right front lower

portion. Vehicle 1 continued through the parking lot of Arrowhead Plaza. Vehicle 1 then struck the curb and

struck the fixed object (Arrowheart Plaza Sign) with it's front portion.

Driver 1 stated he was driving East on Route 88. Driver 1 stated he remembered passing Jay's Garden Center,

however, does not remember anything after that.

Witness 1 stated he was directly behind Vehicle 1. He advice in the area of Jefferson Dr, Vehicle 1 left the

roadway to the right. Vehicle 1 struck a utility pole and continued to through the parking lot and struck the

sign (Arrowheart Plaza Sign).

Brick Police EMS was dispatched and arrived on scene. Driver 1 refused medical treatment.

Vehicle 1 was towed from the scene due to front airbag deployment and it being disabled.

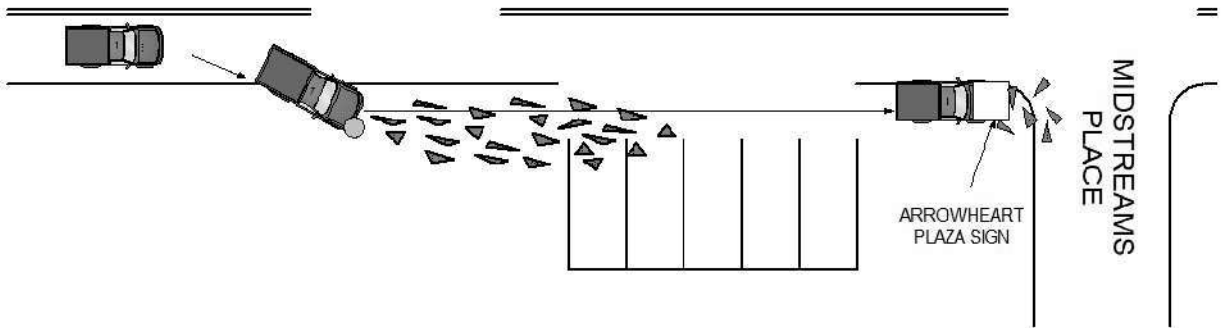
