145. Crash Description/Narrative

A motor vehicle collision occurred on Route 88 west bound approximately 250 feet east of the intersection with Younger Street. Vehicle 02 was traveling straight ahead on Route 88 west bound. Vehicle 01 attempted to make a right turn onto Route 88 west bound from the exit lane of the Walmart (1872 Route 88) parking lot, failed to observe vehicle 02 which was passing by in front of vehicle 01, and the front driver side corner of vehicle 01 struck the rear passenger side corner of vehicle 02.

While on scene, there were no reported injuries and all parties declined medical attention.

Driver 01 stated he was attempting to exit the Walmart parking lot onto Route 88 west bound when he came to a stop at the stop sign. Driver 01 explained he began to make a right turn onto Route 88 west bound and failed to observe vehicle 02 as it was passing by causing the motor vehicle collision.

Driver 02 stated she was traveling straight ahead on Route 88 west bound. Driver 02 explained vehicle 01 struck vehicle 02 as she was passing the Walmart parking lot exit lane and believes an unknown vehicle that was ahead of her blocked driver 01's view.

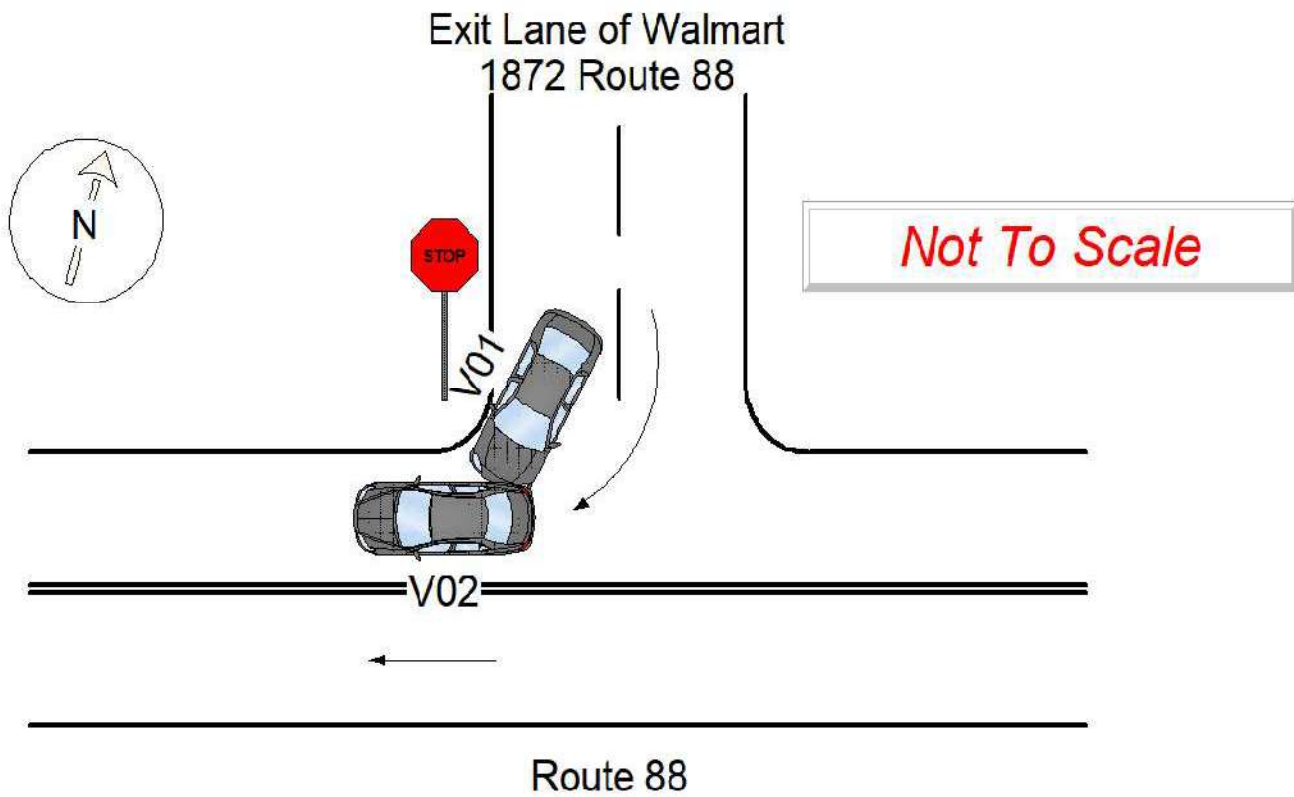
