145. Crash Description/Narrative

Vehicle 01 and Vehicle 02 were both traveling west in the parking lot of 101 Jack Martin Blvd. Vehicle 02 was traveling in the marked drive thru lane of travel. Vehicle 01 attempted to pass Vehicle 02 on the right hand side. While passing Vehicle 02, Vehicle 01 struck the rear of the Vehicle 02 resulting in minor damage.

The operator of Vehicle 02 stated while driving straight in the marked drive thru lane, Vehicle 01 passed him on his passenger side and struck the rear of his vehicle.

The operator of Vehicle 01 reported she was traveling around the drive thru line in an attempt to exit the parking lot. While driving she lightly struck the rear of Vehicle 02.

Based on observation and statements made on scene Vehicle 01 was determined to be at fault.

Department issued BWC activated.

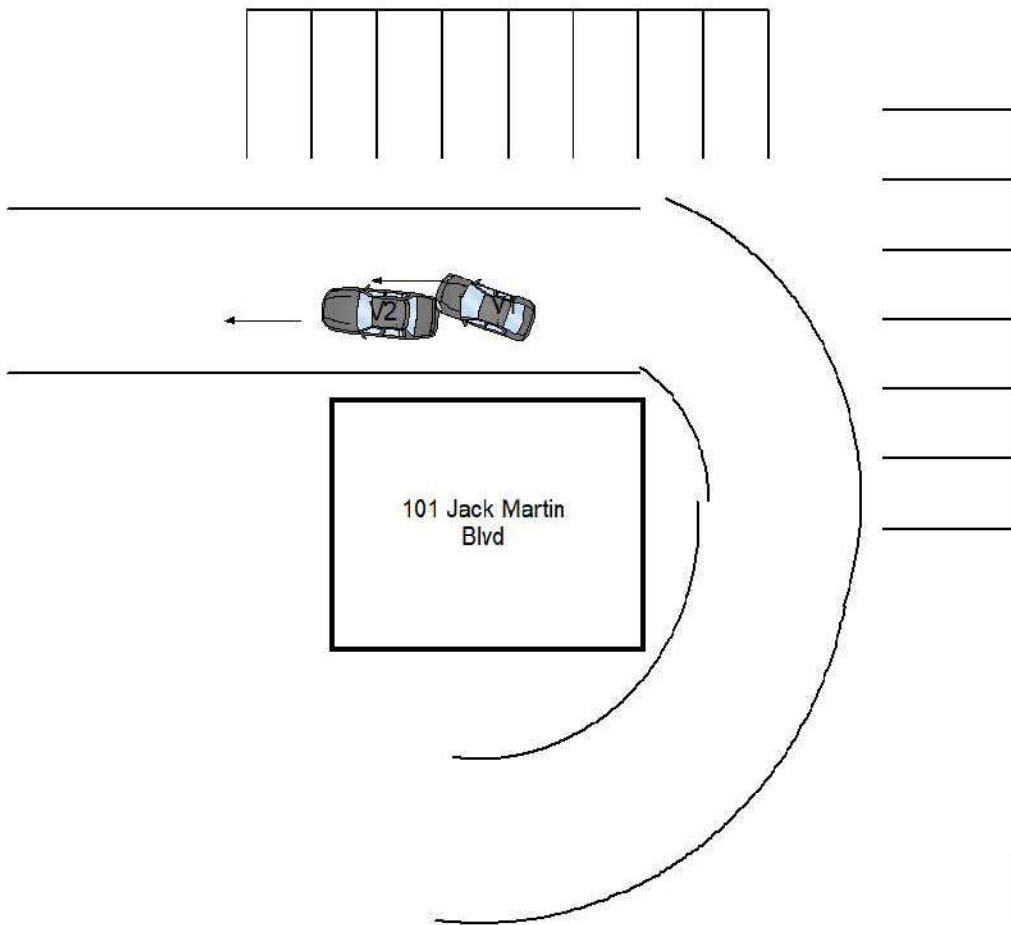
