145. Crash Description/Narrative

Vehicle 1 was traveling directly behind vehicle 2, east on Jack Martin Boulevard just west of Quadara Boulevard. Vehicle 2 was slowing for traffic when vehicle 1 rear ended vehicle 2.

Driver 1 stated she was traveling east on Jack Martin Boulevard directly behind vehicle 2 and vehicle 2 stopped abruptly. Drive 1 stated she was not able to stop in time and rear ended vehicle 2.

Driver 2 stated she was traveling east on Jack Martin Boulevard, slowing in traffic, just west of Quadara Boulevard. Driver 2 stated she observed vehicle 1 traveling behind her at a high rate of speed. Driver 2 stated she was unable to avoid a collision and braced for impact. Driver 2 stated she was rear ended by vehicle 1.

A witness on scene advised that traffic east on Jack Martin Boulevard was travelling at a slow rate of speed, approximately ten miles per hour. The witness indicated he observed vehicle 1 slam into the back of vehicle 2, further stating it appeared the driver was not paying attention. The witness completed a Motor Vehicle Crash Statement Form Witness Statement.

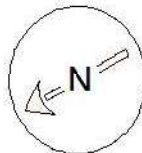
