145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a rear end crash while traveling eastbound on RT 70 in the left lane.

The Driver of Vehicle #1 stated she was traveling behind Vehicle #2 on RT 70 when both vehicle came to a stop at the traffic light at the intersection of RT 70 and Van Zile Road. Driver #1 stated the traffic light then turned green at which time she released her foot off the brake of her vehicle in anticipation of Vehicle #2 traveling forward. Driver #1 stated Vehicle #2 remained stopped and the front end of her vehicle collided with Vehicle #2 rear end.

The Driver of Vehicle #2 stated she was stopped at the above mentioned traffic light when vehicle #1 collided with the rear end of her vehicle. Driver #2 had a complaint of back pain and was evaluated by EMS but ultimately denied further medical treatment.

Based on my observations and statements made by both parties I found the Driver of Vehicle #1 at fault for the crash.

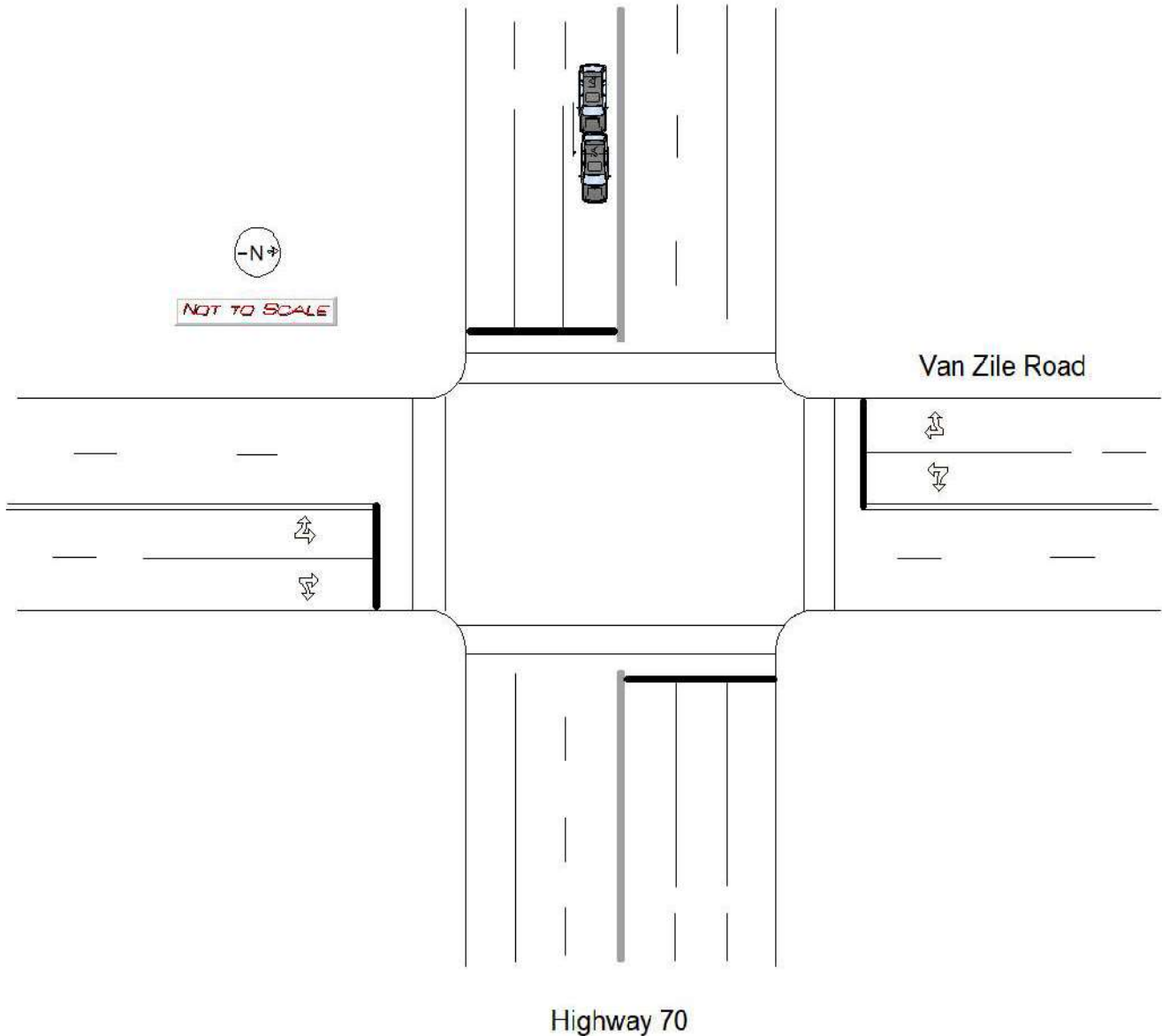
