145. Crash Description/Narrative

Both Vehicles 01 and 02 were traveling south on Burrsville Road. Vehicle 02 was stopped in traffic when Vehicle 01 struck the rear of Vehicle 02.

The operator of Vehicle 02 advised she was stopped on Burrsville Road due to the vehicle in front of her was stopped attempting to make a left-hand turn. The operator further reported it was at this time her vehicle was struck by Vehicle 01.

The operator of Vehicle 01 advised he was traveling south on Burrsville Road. He further reported he saw vehicle 02 was stopped in traffic and attempted to stop his car. He advised due to the wet road conditions. His vehicle would not stop causing him to strike the rear of Vehicle 02.

Both operators were assessed on the scene by the Brick Township Police EMS. Both operators declined further medical attention at this time.

Based on observations and statements made on the scene, Vehicle 01 was determined to be at fault. The operator of
